Sir,

I am directed to inform you that an assessment to verify the compliance submitted by the college authorities on the deficiencies pointed out in the assessment report (8<sup>th</sup> June, 2018) with regard to Recognition/Approval of Government Medical College, Nizamabad, Telangana for the award of MBBS degree (100 seats) granted by Kaloji Narayana Rao University of Health Sciences, Warangal, Telangana u/s 11(2) of the IMC Act, 1956 was carried out by the Council assessors on 29<sup>th</sup> October, 2018. The compliance verification assessment report (29<sup>th</sup> October, 2018) alongwith the summary/observations of the Consultant (Undergraduate) was considered by the Board of Governors and it was decided to recommend to the Central Government for recognition/approval of Government Medical College, Nizamabad, Telangana for the award of MBBS degree (100 seats) granted by Kaloji Narayana Rao University of Health Sciences, Warangal, Telangana u/s 11(2) of the IMC Act, 1956.

The Board of Governors further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16<sup>th</sup> April 2010 and act accordingly at appropriate time, which reads as under:-

8 (3) ...

- (2) The recognition so granted to an Undergraduate Course for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.
- (3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.
- (4) Failure to seek timely renewal of recognition as required in sub-clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute."

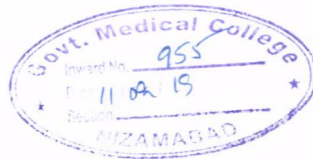
